* De-Minimis Aid is aid provided under the European Commission Regulation on De-Minimis Aid (ie small amounts of state aid up to €200,000 in any 3 year period to any one enterprise are regarded as too small to significantly affect trade or competition in the Common Market). Such amounts are regarded as falling outside the category of state aid that is banned by EC Treaty and can be awarded without notification to or clearance by the European Commission. Where the enterprise has been in receipt of €200,000 in De-Minimis Aid in the last 3 year period, from a state, semi state agency, it will not be eligible for a training subsidy under this programme. In the case of a participant (and not their employer) paying the training organisation in respect of the training, the De-Minimis Aid rule will not apply.
